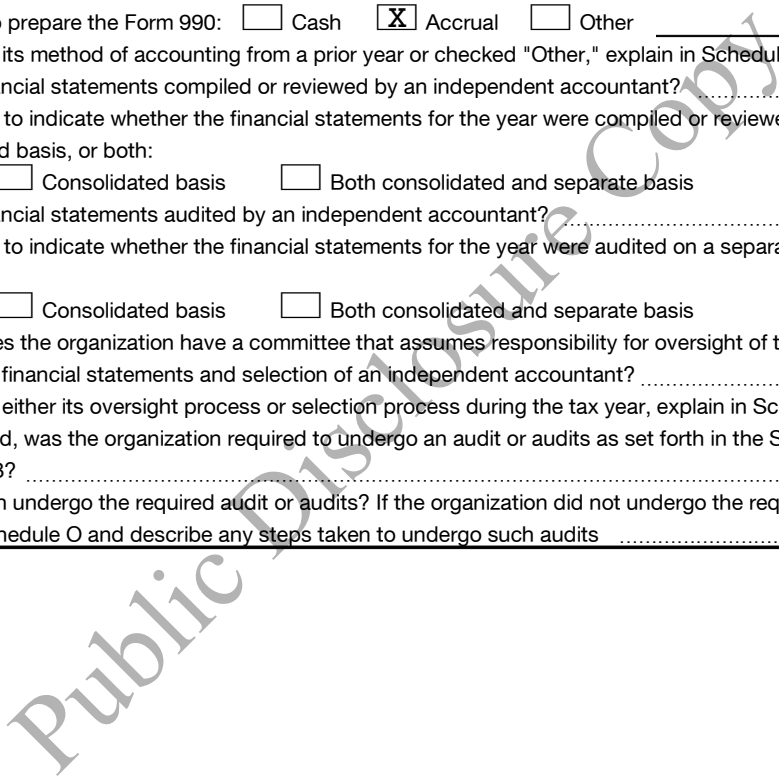

211 connects people with opportunities to "give help" as well as "get help." 211 provides an easy to remember number for individuals interested in volunteering to call and be directed to various volunteer projects in the community.

In this last fiscal year (October 1, 2017-September 30, 2018), highly trained 211 contact center staff handled 167,044 calls, emails, and text messages from local residents seeking assistance. 211 continues to provide intensive support and in some instances life-saving assistance to callers in need of immediate intervention. 13,486 callers identified having minor children in the home; 6,945 callers were older adults 65 years or older; 6,026 callers identified as military veterans; 5,725 callers were provided telephone reassurance/emotional support; 142 active suicides were prevented; 1,128 sexual assault calls were connected to sexual assault services.

211 identified 131,720 needs.
